II. Welcome Address

Dr. (**Mrs.**) **U. Jerinabi**, Dean, Faculty of Business Administration welcomed all the Academic Council members.

 - Candidates with at least fifty percent marks either in the Bachelors Degree and/or in the Masters degree in Sciences/Social Sciences/Humanities. Bachelor's in Engineering or Technology with specialization in Science and Mathematics with 55% marks or any other qualification equivalent thereto, are eligible for admission to the programme.
 - ii) The reservation and relaxation for SC/ST/OBC/PWD and other categories shall be as per the rules of the Central Government/State Government, whichever is applicable.

The above (i & ii) approved.

b) RCI in its letter No. 8-165/B.Sc. Ed. & Reh./12/RCI/4633 dated 17th July, 2015 conveyed its approval for B.Sc. (Special Education & Rehabilitation) for a duration of 3 years for four academic sessions, i.e., 2012-2013, 2013-2014, 2014-2015 & 2015-2016 with a student intake of 30.

The Academic Council members were informed on the above.

The Vice Chancellor made an observation that the department should assess the candidate properly before registration and select the candidates only of good quality for Research and for Languages Communication ability that should be given prior importance.

d Pre-determined strength for M.Phil. and Ph.D. admission

The Vice Chancellor asked to delete the point 48(d) pages from 18 to 23.

e. (i) The predetermined strength for Ph.D. / M.Phil. Guideship

The Vice Chancellor asked to change the head of Item 48e(i) as '**The predetermined strength for Ph.D. guideship**' and suggested to increase the student intake of Postgraduate and Ph.D. programmes rather than Undergraduate and M.Phil. programmes.

e. (ii) Pre-determined Strength for Ph.D. Admission (in case of increase in number of scholars for the faculty)

The Academic Council **approved** the predetermined strength for Ph.D. admission from the academic year 2015-2016 & onwards.

49.Decision to be taken regarding a special case in B.Sc. B.Ed. programme of 1992 Dr. (Mrs.) A. Venmathi, Registrar (i-c) moved the same.

The Vice Chancellor suggested to re-write the notes of the Item No. 49 based on the action taken and to be sent in circulation for information of the Academic Council members.

- This University introduced an Integrated Five Year course in Special Education and Community Based Rehabilitation leading to B.Sc., B.Ed. and M.Ed. for training Teachers in Special Education for Schools. (Approved by the UGC vide its letter No. F.16-1/91 (HR-II/RBA-III dated 18.12.1991 and passed in the 17th Syndicate meeting held on 11.6.1992.)
- Mrs. P. Thamilarasi (Reg. No. 92UR07) was the first batch student enrolled in 1992 in the Integrated Five Year course in Special Education (B.Sc., B.Ed.& M.Ed.) and CBR.
- She was allowed to continue the course of the study upto 5 years and completed M.Ed. in 1997, since it is an Five Year Integrated Programme.
- For the first batch, students with arrears were also permitted to proceed with B.Ed. programme, since it was a Five Year Integrated Programme.

- This candidate did not complete one of the subject in B.Sc., but proceeded further and completed B.Ed. during April, 1996, M.Ed. during May, 1997 and B.Sc. in June, 1997, but the degrees were awarded only after completion of all the papers, i.e. in 1997 (**16.10.1997**).
- Rules were modified which state that, 'Only after clearing all B.Sc. subjects, the students have to be permitted for B.Ed. and thereby M.Ed. programmes'.
- Since it was the first batch and five year Integrated Programme, this mistake had happened.
- Meanwhile, on **5.1.2015**, Mrs. P. Thamilarasi had submitted a letter requesting for clarification from the University regarding the issue of B.Sc. degree after B.Ed. and M.Ed. degrees.
- From the University, a letter has been given stating the inception of 5 year Integrated programme and pattern followed for the first batch of students (Letter No. R/Ac/76 dated January 6, 2015).
- Meanwhile the candidate has filed a writ against Govt. of Tamil Nadu (W.P. No. 6528 of 2015 dated 17.3.2015) in the High Court of Judicature at Madras.

The Academic Council members are requested to give recommendations on the above.

2013-2014, when the University's name has been changed as '**Avinashilingam Institute for Home Science and Higher Education for Women'.**

The above ratified for 2010-2011 batch students of B.Sc., B.Ed. Special Education and Mathematics.

The Vice Chancellor asked to give explanation on the introduction of double major mentioning the importance of introducing a school subject along with the major 'Special Education & Rehabilitation'.

Dr. (Mrs.) Premavathy Vijayan explained as follows:

- UGC vide its letter No. F.16-1/91(HR-II/RBA-III) dated 18.12.1991 conveyed its approval for introduction of an Integrated Five year Course in Special Education and Community Based Rehabilitation for B.Ed./M.Ed. and stipulated that it was for training Teachers for Special Education for Schools. Hence, school subject was needed to meet the objective.
- Hence the school subjects were offered in addition with the Special Education which helped the students completed the programme, to work both in General and Special schools.
- Tamil Nadu Govt. Higher Education (K2) Department G.O. (Ms.) No. 72 dated 30.4.2013 stated the resolution of Equivalence Committee, for the post of Teachers in the School Education Department as 'B.Ed. Special Education is equivalent to that of B.Ed. degree in General Education'.
- 'For Recruitment of Teacher Educators for specialization in Visual Impairment, Masters degree in School subject will be required' as per RCI norms (2009) for Appointment of faculty for B.Ed. and M.Ed. Special Education, which indicates the significance of school subject, thereby necessitates the offering of double major subjects.
- RCI vide its letter No. 8-165/B.Sc. Ed. & Reh./12/RCI/4633 dated 17th July, 2015 conveyed its approval to run the course B.Sc. (Special Education & Rehabilitation) for a duration of 3 years with a student intake capacity of 30 for four academic sessions, i.e. 2012-2013, 2013-2014, 2014-2015 & 2015-2016. Mathematics being a school subject for all and if offered along with Special Education and Rehabilitation would provide much scope for employment in schools.

Hence the University preferred to offer the double major B.Sc. (Special Education and Rehabilitation) and Mathematics.

51. Dr. (Mrs.) Premavathy Vijayan, Faculty of Education moved the same.
