iv. **Mode of Terminal Semester / Final Year Examinations (2019-2020)**

The universities are required to complete the examinations by the end of September 2020 in offline (pen & paper) / online/ blended (online + offline) mode following the prescribed protocols / guidelines related to the COVID-19 pandemic.

**ii. Provision of Examination through Special Chance**

In case a student of the terminal semester/ final year is unable to appear in the examination conducted by the University for whatsoever the reason(s) may be, he/she may be allowed to appear in special examinations for such course(s)/ paper(s), which may be conducted by the University as and when feasible so that the student is not put to any inconvenience/ disadvantage. The above provision shall be applicable only for the current academic session 2019-2020 as a one-time measure.

**iii. The backlog of Papers in respect of Terminal Semester(s)/ Final Year Students**

The students of terminal semester/ final year students having backlog should compulsorily be evaluated by conducting examinations in offline (pen & paper)/ online/ blended (online + offline) mode as per feasibility and suitability.

**As per the UGC guidelines, the Institute conducted the examinations for all the UG/PG programmes of passed out and final year students arrear papers and published the results on 28.08.2020 and was ratified by the Academic Council.**

- b. For intermediate semester/year students, the universities may conduct examinations, after making a comprehensive assessment of their level of preparedness, residential status of the students and status of COVID-19 pandemic spread in different region / state and other factors.

In case the situation does not appear to be normal in view of COVID-19, in order to maintain “social distancing”, safety and health of the students, grading of the students could be composite of 50% marks on the basis of the pattern of internal evaluation adopted by the universities and the remaining 50% marks can be awarded on the basis of performance in previous semester only (if available). The internal evaluation can be continuous evaluation, prelims; mid-semester, internal assignments or whatever name is given for student progression.

In the situations where previous semester or previous year marks are not available, particularly in the first year of annual pattern of examinations, 100% evaluation may be done on the basis of internal evaluation.



If the student wishes to improve the grades, he/she may appear in special exams for such subjects during next semester.

**As per the above-said guidelines, results were processed and published on 28.08.2020 for all the regular UG and PG programmes. The Academic Council ratified the Examinations held, results passed and published in August 2020.**

**c. Submission of M.Phil.and Ph.D. dissertation and conduct of pre synoptic presentation and DC meetings**

As per the UGC guidelines 6 months extension will be allowed from the actual date of submission without any payment of extension fee for 6 months. Conduct of pre synoptic, DC meeting and Ph.D. Viva Voce through online mode with prior permission from the Vice Chancellor, Director (Research and Consultancy), Controller of Examinations and the concerned Deans. Hard copy of the report to be submitted after reopening of the Institute. The programmes are to be recorded and submitted to the Controller of Examinations for further proceedings. The Guidelines for Ph.D. Viva Voce approved by the Research Advisory Committee and the Examination Committee was circulated (**Annexure – 42.2**). **The Academic Council ratified the same.**

**c. Other issues related to Research Activities**

**i. Attendance norms for Full Time Ph.D. scholars**

As approved in the 39<sup>th</sup> Academic Council Meeting held on 28.06.2019, following are the steps to be followed for Full Time Ph.D. scholars:

1. 80 Percentage attendance is required per semester for Full Time Ph.D. scholars.
2. If attendance is less than 80% per semester, the scholar has to pay a penalty of Rs.10,000/- before moving to the next semester.
3. i. If the scholar is absent for a long period, routine intimation should be done by the Supervisor through Email to the scholar;  
ii. Then it should be intimated through registered post;  
iii. If no response within 15 days another registered post should be sent intimating cancellation of registration.  
iv. Intimation to be sent to the office about cancellation of registration.  
v. Then the Supervisor may be officially informed by the Director (R&C) that she is relieved from guiding that scholar and the scholar cannot utilize the data and the research work carried out so far, if she makes any attempt to seek guidance from another Supervisor within the Institute or elsewhere.

**ii. MoU with ICMR-National Institute of Nutrition**

RAC members scrutinized the draft MoU sent by Dr.Subba Rao M Gavaravarapu, Scientist E, Deputy Director , ICMR- NIN, Hyderabad

1. It was suggested that scholars from NIN can register for Ph.D. in Food Science and Nutrition and allied fields in our Institute and have the Supervisor from Avinashilingam Institute, the place of registration and have subject experts in NIN as co-guides, after getting approval from RAC.

2. Scientists D with MD/MPH/Ph.D. in Health, Life Sciences or Social and Behavioral Sciences can be the co-guides, if the Ph.D. topic is relevant for them for guiding.
3. The MoU may be valid for 5 years from the date of signing.
4. Full time and Part time Ph.D. norms have to be followed as per Institute's Ph.D Regulations.

**iii. Plagiarism check of M.Phil. and Ph.D. thesis**

- (i) Chapters to exclude – Review of Literature, Experimental Protocol in Methodology / Experimental Design / Work Plan, Bibliography, Appendices
- (ii) Allowance of 14 consecutive words similarity
- (iii) Plagiarism level upto 10 % permissible as per UGC norms
- (iv) Library has to receive from the Supervisor, a note that no further alterations or changes will be made in the thesis after plagiarism check and the same soft copy (CD) has to be submitted to the Controller of Examinations.
