- d. **Conducting Make up and Summer Supplementary** Examinations for Bachelor of Engineering students admitted from the academic year 2017-18 and onwards as given in Annexure 38.3a and Annexure 38.3b were ratified.
- e. **Special Comprehensive Examinations** conducted for the students who represent the University in any event with prior consent of the Vice Chancellor, and the results of the same published along with regular results, was ratified.
- f. **Modification and inclusion of items in Statement of Marks and Consolidated Statement of Marks format as per UGC norms** (Letter D.O.No. F.1-1/ 2014 (secy) dated 18th November 2014 and D.O.No.F.9-1/2014 (CPPI-II) dated 21st March 2017.) for all the students of all courses admitted from the Academic year 2016-17 and onwards as given in Annexure 38.4 was ratified.

g. Approval for Plagiarism Limit

With the objective of maintaining the academic integrity and to identify any act of dishonesty in research work, plagiarism check of all research work and publications is essential. Hence the plagiarism limit suggested is as follows:

- M.Phil/Ph.D dissertation work upto 15% of Plagiarism is acceptable for chapters on Introduction, Methodology, Results and Discussion and Summary and conclusion respectively
- No plagiarism check for chapter on Review of Literature
- The Research Articles and other publications upto 15% plagiarism is acceptable.

The above points applicable from the academic year 2018-2019 and onwards were approved.

- i. **Approval for number of attempts and time period to complete the M.Phil. and Ph.D. Programme Part I course work applicable for the scholars admitted from the academic year 2018-2019 and onwards.**

All candidates admitted to M.Phil. and Ph.D. programmes shall be required to complete the course work prescribed by the department during first appearance (after the completion of six months for full time candidates and after the completion of one year for part time candidates) or in two consecutive reappearances (in the interval of once in six months) was approved.

- j. **Information on National Academic Depository (NAD)**

National Academic Depository (NAD) which is an online store house of academic awards (degrees, diplomas, certificates, mark sheets etc.,) lodged by the boards/ academic institutions/ eligibility assessment bodies in a digital format, has been launched on 9th July, 2017 by Hon' ble President of India. It is a 24x7 online mode for making available academic awards and helps in validating its authenticity, safe storage and easy retrieval. The Ministry of Human Resource Development (MHRD) has designated the University Grants Commission (UGC) as an authorized body for the implementation of NAD. NSDL Database Management Limited (NDML) and CDSL Ventures Limited (CVL) are MHRD and UGC approved digital depositories for NAD who will keep the academic awards in the digital format and ensure the data integrity. In this connection CDSL gave the presentation on 28.11.2017. The authorities of the Institute satisfied with their work and signed a Service Level Agreement with M/s. CDSL on 23.2.2018. Work in process.

This was for information to the Academic Council.

The Chairperson of the Academic Council **Dr. (Mrs.) Premavathy Vijayan** informed regarding the communications received from the UGC.

39.1 Information on Inclusion of course module of Consumer Affairs at Under Graduate level as an elective course

University Grants Commission in its letter No. F. 14-1/2017(CPP-II) dated 9th February, 2018 asked the Universities/Colleges to include the course module of **Consumer Affairs** prepared by the Expert Committee at Undergraduate level as an elective course.

The University has introduced the course on Consumer Affairs as a Generic Elective course for Undergraduate students admitted from the academic year 2018-2019 & onwards.

39.2 Consideration of starting an elective course related to Swachha Bharat Abhiyan activities under Choice Based Credit System (CBCS) from the forthcoming summer session

UGC in its letter F.No. 9-10/2018(CPP-II) dated 23rd March, 2018 asked the Universities to start an elective course related to **Swachha Bharat Abhiyan activities** from the forthcoming summer session. Accordingly, the Universities are requested to consider providing **an elective course** under CBCS **with two credits for 15 days (100 hours) Summer Internship.**

The University will implement/include the course as one of the Co-curricular course from the academic year 2018-2019 and onwards.

39.3 Information on offering M.Phil. and Ph.D. programmes through distance learning mode

UGC in its letter F. No. 4-1/2016 (DEB-III) dated 31st May, 2017 stated as follows:

‘As per UGC (Minimum standards and procedure for awards of M.Phil./Ph.D. Degree) Regulations, 2016, **no University/Institution is allowed to offer M.Phil. and Ph.D. programme through distance learning mode.**

Students are advised not to take admission in any M.Phil./Ph.D. programme, if offered by any University/Institution **through distance learning mode.**

It is informed that UGC has allowed Indira Gandhi National Open University (IGNOU), and some other State Open Universities to conduct M.Phil./Ph.D. programmes in **non-technical programmes in “Regular (full-time/part-time) mode”** only provided these Universities abide by the UGC (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degrees) Regulations, 2016 and have specific approval of the UGC”.

This was for information.

39.4 Considering Degrees/Diplomas/Certificates awarded for programmes conducted by the Open and Distance Learning Institutions (ODL)

UGC through its Public Notice F.No. 1-9/2018 (DEB-I) dated 23rd February, 2018 stated as follows:

The Government of India has envisaged a greater role for the Open and the Distance Education System. The envisioned role may be fulfilled by recognizing and treating the Degrees/Diplomas/Certificates awarded through distance mode at par with the corresponding awards of Degrees/Diplomas/Certificates obtained through the formal system of education. Open and Distance Education System in the country is contributing a lot in expansion of Higher Education and for achieving target of Gross Enrolment Ratio, without compromising on quality. Non recognition/non equivalence of degrees of Open and Distance Learning (ODL) institutions for the purpose of promotion/employment and pursuing higher education may prove a deterrent to many aspiring students and will ultimately defeat the purpose of Open and Distance Education.

Accordingly, **the Degrees/Diplomas/Certificates awarded for programmes conducted by the ODL institutions, recognized by the erstwhile DEC/UGC**, in conformity with UGC Notification on **Specification of Degrees** should be **treated as equivalent** to the corresponding awards of the Degree/Diploma/ Certificate of the traditional Universities/Institutions in the country.

UGC has notified UGC (Open and Distance Learning) Regulations, 2017 in the official gazette on 23.6.2017. As per UGC (Open and Distance Learning) Regulations, 2017 under Part-I (2)(p), **the programmes in engineering, medicine, dental, pharmacy, nursing, architecture, physiotherapy and such other programmes which require hands-on training are not permitted to be offered under Open and Distance Learning mode.**

39.5 Information on agenda points of the ensuing Civil Military Liaison Conference – vacancy in Professional Course

Higher Education (J1) Department, Chennai through its letter No. 22180/J1/2017-2 dated 11.5.2018 requested the University to send the remarks on the agenda points of the ensuing Civil Military Liaison Conference.

Agenda Point 36 – **Vacancy in Professional Course – reservation for wards of Ex-servicemen in Professional Educational Institutions.**

In this University, preference is given for wards of Ex-Servicemen in admission and one seat for B.Ed. is allotted under ex-servicemen quota, in the academic year 2018-2019.

39.6 Information on SWAYAM's MOOCs Courses

UGC in its letter F. No. 1-8/2017 (SWAYAM Board) dated 1st May, 2018 stated as follows:

“SWAYAM is an indigenous platform of the Government of India, which hosts MOOCs (Massive Open Online Courses) to enable students to virtually attend the courses taught by the best faculty; access high quality reading resources; participate in discussion forums; take tests and earn credits as per the UGC Regulations, 2016. The SWAYAM announces the courses every semester in advance to enable the universities to choose the best courses for their students in the coming Semester.

The Consolidated list of MOOCs courses which are being offered in the forthcoming academic session commencing July, 2018, by the nine National Co-ordinators identified by Government of India from School to Higher Education level on SWAYAM, is available at <http://ugcmoocs.inflibnet.ac.in/courses.php>.

The University has already included MOOCs courses at Postgraduate level, for students admitted from the academic year 2017-2018 & onwards, and planning to adopt the MOOCs with additional credits through SWAYAM platform for the Undergraduate students admitted from the academic year 2018-2019 and onwards.

2. Part Time PhD Admission for Candidates from Industries

RAC recommended Part Time PhD admission to candidates from industries if they satisfied the following criteria:

1. The industry where the candidate is employed should be a registered firm in existence for at least for five years
2. The industry should have a minimum of 15 employers
3. The candidate should have a continuous service of atleast two years
4. The candidate should produce a no objection certificate from the employer.
5. The candidate should be permitted to put in 45 days attendance per year during the programme period.
6. Every six months the candidate should produce a certificate from the employer about their service status.

The Academic Council was requested to approve the above.

Since the admission of industrial candidates was approved by the Academic Council, the pending PhD admission of three candidates during July 2017 session will be included during the current year admission list.

The Academic Council members discussed on the part time Ph.D. admission for candidates from industries and the department of Music, Computer Science, Business Administration, Food Service Management and Dietetics, Textiles and Clothing and Engineering expressed their willingness to have Ph.D. candidates from industries.

Dr. Ram Ganesh and Dr. Mohan suggested to reduce the number of days for attendance as 30 instead of 45. The Academic Council members discussed on the same. After discussion, the Chairperson of the Academic Council informed that the contact days might be retained as 45.
