- 2. Late and in-complete application will be summarily rejected.
- 3. Women candidates only need to apply except for "Finance Officer" Post for which Men and Women candidates may apply.
- 4. Mere possession of eligibility conditions for the post shall not entitle a candidate to be called for Interview / Skill Test and for selection.
- 5. Age relaxations as per Govt.of. India norms. Departmental Candidates seeking age relaxation must justify their claim.
- 6. The crucial date for determining the age limit shall be the closing date for receipt of applications from candidates in India.
