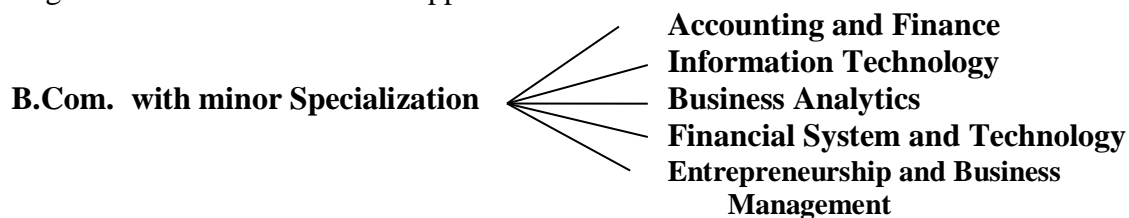

It is for the information of the general public and all concerned stakeholders that in the exercise of its powers given under the UGC Act, 1956 (as amended): UGC has notified the University Grants Commission (Academic Collaboration between Indian and Foreign Higher Education Institutions to offer Twinning Programme, Joint Degree, Dual Degree Programmes) Regulations, 2022 and University Grants Commission (Setting up and Operation of Campuses of Foreign Higher Educational Institutions in India) Regulations, 2023.

**The Regulations mandate that No Foreign Higher Educational Institution shall offer any programme in India without the prior approval of the Commission.**

The regulations also mandate that the HEIs shall not offer programmes under any franchise arrangement and that such programmes shall not be recognised by the UGC.

University Grants Commission has observed and has been informed that many HEIs/colleges have entered into collaborative agreements/arrangements with foreign-based educational institutions/providers not recognized by the Commission and have been facilitating the issuance of degrees to the students enrolled in those institutions/college from such foreign-based educational institutions/educational providers.

Any such kind of collaboration/ arrangement is not recognized by the University Grants Commission and accordingly, the degrees issued subsequent to such collaboration arrangement are also not recognized by the Commission.

- p. **Removal of non CGPA - 2 credit MOOC** over and above 165 credits (as already 2 MOOC courses are included in Part III with credit transfer), for all the students admitted in the **B.E. Programmes** from the academic year 2024-2025 & onwards was approved.
- q. **Change in Evaluation Pattern for MOOCs** applicable for the B.E. students admitted from 2020-2021 & onwards and M.E. students admitted from 2022-2023 & onwards was approved.
- If the student scores between 40 and 49 marks out of 100 in NPTEL exam and receives NPTEL certificate, relational value of 50 marks can be fixed.
  - If the student scores 50 & above marks in NPTEL exam and receives NPTEL certificate, only absolute value of the marks can be considered.
  - Till 7<sup>th</sup> semester of B.E. and 3<sup>rd</sup> semester of M.E. if the student scores less than 40 marks out of 100 and did not receive NPTEL certificate or if the student scores more than 40 marks out of 100 without satisfying minimum passing criteria of NPTEL and not receiving the NPTEL completion certificate, the student may be permitted to appear for an in-house Comprehensive Examination conducted by the Institute **at the end of the 7<sup>th</sup> semester of B.E. and 3<sup>rd</sup> semester of M.E.** for the course title already enrolled in

NPTEL. In case of failure in the in-house examination, they may be permitted to appear for in-house arrears examination.

*Dr.N.Mathivanan, informed that the infrastructure and faculty should be considered, while increasing the student intake.*

*The Vice Chancellor Dr.(Mrs.)V.Bharathi Harishankar explained on the nomenclatures specified for the newly introduced programmes; asked to modify the agenda item (d) as “Suspension of B.E. Printing Technology and closure of M.Tech. Electronics and Communication Engineering (Internet of Things) programmes ....” and in agenda item (q), change in the Evaluation pattern for MOOCs, for the existing batches, it may be “ratified”. The Chairperson also suggested to bring the aspects discussed in ‘q’, that is, conducting in-house examination for each semester, in each Academic Council Meeting.*

**Dr. (Mrs.) P.Santhi**, Dean & Professor, Department of Commerce seconded the motion.

The motion was passed unanimously.
